Rules for Exhibits

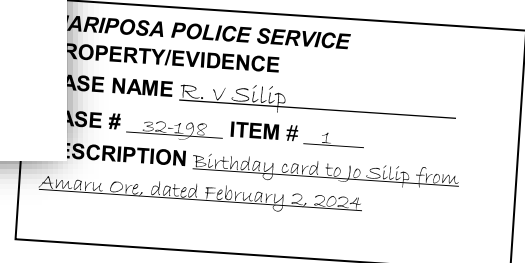
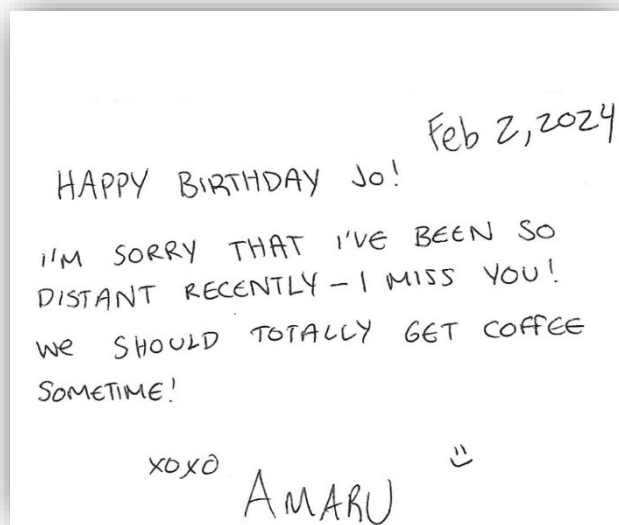

Foundation for the exhibit can be established by referencing that the exhibit was previously verified under oath by the Crown prior to the start of the mock trial. The first time an exhibit is entered, the copy that was entered becomes the “real” exhibit, and subsequent counsel will need to ask for the exhibit from the court clerk in order to put it to a witness.
